Once I receive my confirmation notice, I have ten (10) business days to notify Prime Resorts International customer service in writing of my intent to cancel and receive a full refund as more fully set forth below in the mandated disclosure requirements.

I understand that I am paying Prime Resorts International a one time non reoccurring advertising fee, to advertise my timeshare for a period of ninety (90) days. If I have not received an acceptable offer within ninety (90) days, Prime Resorts International will renew my advertising at the company's expense if notified every ninety (90) days. I understand that during the initial ninety (90) day period, if my timeshare is sold by a broker, firm or another company with in 25% or higher of the advertised price, I am to provide Prime Resorts International proof of the sale and Prime Resorts International will refund my full advertising fee.

I understand that Prime Resorts International will advertise my timeshare for sale anytime in the future at no additional cost to me. I understand I may advertise my timeshare for sale at no additional cost in the future.

# Prime Resorts International

Pursuant to Florida Statute 721.205, Subscriber understands that:

1. Upon the sale of a timeshare, additional cost to third parties over which Prime Resorts International has no control may be due including resort transfer fees, title fees and costs, government recording fees and taxes. 721.205 (1)(a)1 and 2, F.S.
2. We recommend Subscribers utilize a licensed title agency or an attorney to administer the transfer of a timeshare to avoid falling victim to fraud or excessive demands by a third party.
3. The owner of the timeshare remains obligated for all fees and costs associated with the timeshare payable to any owner association, finance company or other provider with whom the owner has contracted. 721.205 (1)(a)1 and 2, F.S.
4. Neither Prime Resorts International nor its agents have stated or implied that Prime Resorts International will provide direct sales or resale brokerage services other than the advertising of the Timeshare Ownership(s) for sale or rent by Subscriber. 721.205 (2)(a), F.S.
5. Neither Prime Resorts International nor its agents have stated or implied, directly or indirectly, that Prime Resorts International has already identified a person interested in buying or renting the timeshare resale interest. 721.205 (2)(b), F.S.
6. Neither Prime Resorts International nor its agents have stated or implied, directly or indirectly, that sales or rentals have been achieved or generated as a result of its advertising without providing documentation substantiating the statement. 721.205 (2)(c), F.S.
7. Neither Prime Resorts International nor its agents have stated or implied that the timeshare has a specific resale value. 721.205 (2)(d), F.S.
8. Prime Resorts International has not charged Subscriber's card or received any compensation for resale advertising services prior to Subscriber's written Agreement. 721.205 (2)(e) and f, F.S. has been achieved or generated as a result of its advertising services without providing documentation substantiating the statement. 721.205 (2)(c), F.S.
9. When you find a buyer; your resale contract must comply in all respects with 721.065, F.S., including the provision of the 10 day cancellation period for the prospective consumer resale purchaser. 721.205 f (4), F.S. If you need help drafting a contract with a buyer, you should contact a Timeshare Attorney that can assist you.

## **TIMESHARE OWNER'S RIGHT OF CANCELLATION**

Prime Resorts International will provide resale advertising services pursuant to this contract. If Prime Resorts International represents that Prime Resorts International has identified a person who is interested in purchasing or renting your timeshare interest, then Prime Resorts International must provide you with the name, address, and telephone number of such represented interested resale purchaser.

You have an unwaivable right to cancel this contract for any reason within 10 days after the date you sign this contract. If you decide to cancel this contract, you must notify Prime Resorts International in writing you intent to cancel. Your refund will be made within 20 days after receipt of notice of cancellation or within 5 days after receipt of funds from your cleared check, whichever is later.

You are not obligated to pay Prime Resorts International any money unless you sign this contract and return it to Prime Resorts International
